In accordance with the terms of the Court's Order of November 27, 2023, a recount of the election for the Clerk of the Circuit Court for Page County, Virginia, that was held on November 7, 2023, was performed by the recount officials under the supervision of the Court in accordance with the provisions of §24.2-800 et seq. of the Code of Virginia, 1950, as amended.




The Clerk shall certify a copy of this Order to the Page County Electoral Board; the Virginia State Electoral Board; and to the parties.

There being nothing further to be done in this matter the Clerk is directed to remove this case from the active docket of this Court and place it among the ended causes.


